

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to 302 Campusview Dr, and Simplified SEO Consulting LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Simplified SEO Consulting LLC include 302 Campusview Dr and Simplified SEO Consulting. ## Collection of your Personal Information
